Terms and Conditions

These terms relate to the '**WIN a family holiday from Teesside Competition** (the '**competition**') which is run and promoted by Teesside International Airport Limited (a company registered in England with company number 02020423), whose Registered office is Cavendish House, Teesdale Business Park, Stockton-on-Tees, Tees Valley, England, TS17 6QY (the '**Airport**', '**we**' or '**our**').

1. By entering the competition, you accept these terms and conditions.
2. These terms are in addition to any conditions detailed in the marketing material about the prize draw (the "**marketing material**").
3. **PURPOSE:** The purpose of this competition is to promote holiday destinations accessible from Teesside International Airport.
4. **HOW TO ENTER:**
 - a. Entry to the competition will be via an online form only, which can be accessed at www.teessideinternational.com/win-a-family-holiday There is no other way to submit an entry.
 - b. **Entries must be submitted by 11:59PM on Saturday 18th June 2022.** Late entries will not be counted.

- e. Neither we nor any Group company accept any responsibility or liability for entries which do not reach us before the closing date or are illegible, incomplete or corrupted. Entrants must have a valid email address to claim this prize.
