

**Teesside International Airport
WIN Beyonce VIP Corporate Hospitality Tickets
Terms and Conditions**

These terms relate to the '**WIN Beyonce VIP Corporate Hospitality Tickets**' (the '**competition**') which is run and promoted by Teesside International Airport Limited (a company registered in England with company number 02020423), whose Registered office is Teesside International Airport, Darlington, DL2 1LU (the '**Airport**', '**we**' or '**our**')

1. By entering the competition, you accept these terms and conditions.
2. These terms are in addition to any conditions detailed in the marketing material about the prize draw (the "**marketing material**").
3. **PURPOSE:** The purpose of this competition encourages travel agents to make bookings for their clients to fly from Teesside International Airport
4. **HOW TO ENTER:**
