

# Teesside International Airport Book Dalaman For Big Delights! Terms and Conditions

These terms relate to the 'Book Dalaman For Big Delights' (the 'competition') which is run and promoted by Teesside International Airport Limited (a company registered in England with company number 02020423), whose Registered office is Teesside International Airport, Darlington, DL2 1LU (the 'Airport', 'we' or 'our')

- 1. By entering the competition, you accept these terms and conditions.
- 2. These terms are in addition to any conditions detailed in the marketing material about the prize draw (the "marketing material").
- 3. PURPOSE: The purpose of this competition encourages travel agents to make bookings for their clients to fly from Teesside International Airport
